# Important information

The orthosis is used according to the recommendations of the specialized physician.

Choosing the size - For optimal results, the appropriate size will be selected based on the measurements table of the product. A size too small may lead to intolerance to wearing or the damage of the product! A size too large significantly diminishes the efficacy of the orthosis.

This orthosis should only be applied in accordance with the instructions mentioned here.

The product is intended for single patient use.

No liability is accepted for incorrect product use.

Guarantee is bound to statutory regulations.

#### Available sizes

Universal size

For ankle with circumference between 20 - 30 cm.

#### Indications

It is used in cricks, luxations, post consolidated fractures, inflammatory processes, after the removal of the orthopedic plaster cast.

#### Description

Orthosis with anatomical design, made of textile, provided with:

- 2 elastic straps crossed around the ankle for compression and fastening, which can be repositioned as needed (the 2 elastic straps are provided with 2 pockets for the metal splints. These elastic straps can be removed or repositioned according to ankle circumference)
- 2 metal side splints, one on each side
- 2 flexible metal splints, one on each side. For a perfect fit at the malleolus, the 2 splints from both sides can be switched (the metal one with the flexible one) The heel area is open.

Hook and loop fastener on the front side.

Height: 23 cm.

The orthosis is an ankle support, the 2 flexible metal splints and the 2 metal side splints ensure stability and safety in use. The crossed straps around the ankle and around the 4 splints exert additional compression, making the orthosis an efficient rigid support.

### Composition

Three-layer laminated textile: PA Poliamide – 51,2%, PU Polyurethane – 43,2%, EA Elastane – 5,6%. The laminated textile ensemble behaves like a moisture regulator, ensuring a quick transfer of the moisture to outward.

### Positioning

The orthosis can be used on both limbs and is packed for right side use. To use the orthosis on the left side, please switch on both sides the insertion order of the metal splint and the flexible splint. The orthosis is placed on the foot so that the straps are fastened in the front and the long bands are crossed under the sole and are fastened in the back to the optimal compression.



To be washed by hand with warm water, no bleaching, no spinning, no ironing, no chemical cleaning!

# Storage

At room temperature, in a dry space with good ventilation.

### Commercial warranty of the product: 30 days.

Date of production: see packaging label.

Validity date: no expiry date.

To validate the warranty, the seller must indicate the date of purchase. The buyer is obliged to keep and present the warranty coupon.

In order to solve the problems that appeared in the warranty, the following data must be notified: Article reference, batch and date of manufacture, indicated on the packaging box of the product.
